# TOURNAMENT RULES

## **ENTRIES CLOSE February 9, 2012 -- Squads assigned on a first come, first served basis.**

1. **FORMAT:** This tournament will consist of mixed teams and doubles. Teams will have two women and two men. Doubles will consist of one woman and one man. Entries must include correct mailing address of the team captain and email address if possible.
2. **ELIGIBILITY:** The Mixed Tournament is open to all USBC Members of the Pikes Peak USBC Association. All participants must possess a current USBC Membership at check-in time. Non-USBC Members who reside within the Pikes Peak USBC Area (El Paso and Teller Counties) may qualify by paying an \$18.00 fee for an associate membership card. Any USBC Member who identifies themselves as a "Professional" may participate in this tournament, limiting the number of individuals defined as professional bowlers to one on a four-person team, and one on a doubles team.
3. **DRESS CODE:** NO cutoffs, tank tops, muscle shirts, or headgear. Failure to comply will result in disqualification and forfeiture of entry fee.
4. **AVERAGES:** USE HIGHEST 2010-2011 BOOK AVERAGE OF 21 games or more. If no 2010-2011 average, the bowler may use HIGHEST CURRENT league average of 21 games or more as of February 1, 2012. If the bowler has neither of these averages, an average of 230 will be assigned with no handicap offered. Bowlers required to use current league average must have verification signed by league secretary and verification attached to entry form or presented to the tournament management prior to participating in their first event.
5. **VERIFICATION OF AVERAGES** - It shall be each bowler's responsibility to verify the accuracy of their average, whether submitted by the bowler, the team captain or others. Failure to use the proper average or make the correction prior to the end of the first game of a series shall disqualify the score if the submitted average is lower than the actual average. If the submitted average is higher than the actual average, prize winnings will be based on the submitted average.
6. **USBC RULES 319a Paragraph 2 (10 pin rule), 319d and 319e DO NOT** apply to this tournament.
7. **HANDICAP** - Shall be 90% of 230.
8. **PRIZE RATIOS** for each event will be at least 1 in 8.
9. **SCRATCH EVENTS** - A concurrent Scratch option is offered for this tournament. Participants **MUST** have entered the handicap portion of the event in order to participate in the scratch event. The entire team or doubles pair must enter the scratch event to qualify. The entry fee is \$5.00 per bowler per Scratch Event.
10. **ENTRIES:** Entries paid by check or money order must be made payable to the Pikes Peak USBC (A service fee of \$25.00 will be added for all returned checks). No team or individual shall be entitled to a refund after definite dates and times have been assigned. Entry forms must be postmarked by midnight, February 8, 2012. Phone 390-8129 for reservations (must be paid prior to entry closing date). Entries will be accepted on a first come and apace available until the day before squad time.
11. **SCHEDULING** - Lane assignments are made by the Tournament Manager. Additional squads may be added prior to February 9, 2012. If it becomes necessary to reschedule bowlers in any event, it will be done at the discretion of the Tournament Manager. In the case of a machine failure, and it becomes impossible to complete the event within the scheduled time, the event will be rescheduled, and bowling will resume at the point where bowling was discontinued.
12. **TEAM CAPTAIN** - Is responsible for the submission of each entry and all fees. Entry forms must be completely and legibly filled out to include the team name. The team captain is the team representative and will serve in all matters pertaining to individual behavior and compliance with Tournament and USBC Rules. The team captain is responsible for the appearance of the team at the time and date scheduled to bowl. failure to appear as scheduled will result in forfeiture of entry fees.
13. **REPLACEMENTS** - Authorized by Team Captain, or the authorized representative. Replacements must occupy the same position in the line up as the original entrant. Bowlers will bowl in the order as listed on the original entry form, unless a request for change is made at least one hour prior to squad time. Once a replacement has been added to the roster, and the replacement bowler has delivered the first ball in competition, the replacement bowler must be allowed to complete the 3 game series.
14. **PACERS ARE NOT ALLOWED.**
15. **CHECK IN TIMES** - All participants check in at least 30 minutes prior to squad times.
16. **TARDY BOWLERS.** Tardy bowlers will start in the frame being bowled when they are **READY** for tournament play, with **NO SCORE** for frames missed. Teams refusing to start at the scheduled time due to lack of players will forfeit the right to bowl and all entry fees paid.
17. **LOST SCORES - SCOREKEEPERS** - USBC RULE 327a, USBC RULE 327c.
18. **SCORE SHEETS** - After a score sheet has been signed by the contestant or Team Captain, it cannot be changed except in the case of an obvious error in scoring or calculation. Bowlers are cautioned to sign score sheets only after insuring the scores and calculations are correct. Duplicate recap sheets are available for the bowlers. Tele-scorers or computer printouts will be the Official score sheet. These will be on file for 72 hours.
19. **PROTESTS** - Any protest affecting eligibility or Tournament rules must be confirmed in writing to the Tournament Manager, with a copy to the United States Bowling Congress, before the prize checks have been mailed.
20. **PRACTICE BOWLING** - Ten minutes of practice will be allowed before each session. When tournament lanes are not in use, bowlers may use them for "warm up" purposes at the discretion of the center management, except that all lanes used in tournament play must be cleared 30 minutes prior to squad time.
21. **USBC RULES WILL APPLY IN ALL INSTANCES NOT SPECIFICALLY COVERED BY THE ABOVE RULES.**
